## Firewise Vegetation Management

### **Home ignition Zones**

To increase your home's chance of surviving a wild-fire, choose fire-resistant building materials and limit the amount of flammable vegetation in the three home ignition zones. The zones include the **Immediate Zone**: (0 to 5 feet around the house), the **Intermediate Zone**: (5 to 30 feet), and the **Extended Zone**: (30 to 100 feet).

#### **Landscaping and Maintenance**

To reduce ember ignitions and fire spread, trim branches that overhang the home, porch, and deck and prune branches of large trees up to 6 to 10 feet (depending on their height) from the ground. Remove plants containing resins, oils, and waxes. Use crushed stone or gravel instead of flammable mulches in the **Immediate Zone** (0 to 5 feet) around the house. Keep your landscape in good condition.

#### **Emergency Responder Access**

Ensure your homes have legible and clearly marked address numbers. Driveways should be at least 12 feet wide with a vertical clearance of 15 feet for emergency vehicle access.

Know two ways out of your neighborhood and have a predesignated meeting place.

Always evacuate if you feel it's unsafe to stay—don't wait to receive an emergency notification if you feel threatened from a fire.
