STAFF REPORT:

Chief Swinhart: Chief Swinhart briefly discussed the recent planning meeting with Camas, Washougal and ECFR, he stated that the next step in the process for functional consolidation was to form a joint working group with representatives from both cities and the fire district, he hopes to get that organized and a meeting scheduled in the next couple of weeks. Chief Swinhart informed the Board that he will be out of town on Friday 2-9-18 and return on Tuesday 2-13-18.

Deputy Chief Carnes read his report; a copy is in the packet. Chief Carnes invited the Commissioners to the practice burn-to-learn scheduled for Saturday, 2-10-18 starting at 0800 hours.

Chief Jacobs read his report; a copy is in the packet. Chief Jacobs briefed the Commissioners on the final inspection trip to South Dakota for the new engine and stated that both he and Deputy Chief Carnes were very pleased with the new apparatus. He stated that we are waiting to hear from the vendor for an exact delivery date but should be in the next couple of weeks.

Snure Seminar:

Deputy Chief Carnes presented a class flyer for the upcoming Brian Snure Seminar scheduled for April 21, 2018 to be held at Station 91. The Board reviewed the flyer and asked that we send a copy to Brian for his approval.

Resolution #237-02062018 and Resolution #238-02062018:

These resolutions are for 2 Apparatus that were approved for surplus by the Board at the January 16th Board meeting. There was some discussion on sales price. Chief Carnes stated that he was planning to do some research to get some idea what these apparatuses are worth. Chief Carnes will come back to the Board with some recommendations before advertising them for sale.

C/W Port Water Connection Agreement:

Deputy Chief Carnes presented a document provided by the Port of Camas/Washougal that terminates the ILA for a fire line connection. The Port will not be able to use the fire district's fire line as proposed in the ILA.

Motion by Commissioner Gianatasio to terminate the ILA with the Port of C/W as presented, seconded by Commissioner Petty. Motion passed unanimously.

Consider Purchase Request for AVL Hardware and Fire Com Headsets for new Engine:

Chief Carnes asked the Board to approve a purchase request for AVL and Fire Com Headsets for the new Engine. Both of these are 2018 budgeted items. There was some discussion asking if staff had looked at utilizing the old Headsets off a backup Engine. Chief Carnes stated that staff had discussed all options and it was determined that it would be best and most convenient to leave the old Head Sets on the backup Engine.

Motion by Commissioner Martin to approve the purchase of AVL and Fire Com Headsets, seconded by Commissioner Petty. Motion passed unanimously.

Ordinance # 1836

AN ORDINANCE annexing property to the City of Washougal, known as the "Stalnaker Annexation".

WHEREAS, the property to be annexed is shown on the attached Exhibit "A" which is a map of area to be annexed and as more particularly described in Exhibit "B" which is a legal description of the area to be annexed, both of which are attached hereto and incorporated herein by this reference; and

WHEREAS, at the October 9, 2017 City Council meeting the Council:

- Modified the boundary of the annexation to be that as shown in Exhibit "A" and described in Exhibit "B;
- Required the zoning identified in the preferred alternative plan to apply to the properties upon annexation;
- Required the assumption of all existing city indebtedness by the area to be annexed; and
- Authorized staff to develop a Petition for Annexation for the area and authorize its circulation.

WHEREAS, the City received the Petition for Annexation to initiate the proposed annexation and said Petition was signed by the owners of not less than sixty percent (60%) in value according to the assessed valuation for general taxation of the property described in Exhibit "B"; and

WHEREAS, the petition for annexation was submitted to the Clark County Assessor's Office who certified the signatures on the Petition for Annexation; and

WHEREAS, notice of the hearing was published in the paper and the site was posted on February 2, 2018 consistent with RCW 35A.14.130; and

WHEREAS, notice of the hearing was mailed to all property owners within 500-feet consistent with WMC 18.94.080, and

WHEREAS, all statutory requirements for the annexation have been met; and

WHEREAS, a public hearing was held on February 12, 2018 to take public input on the proposed annexation.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHOUGAL, WASHINGTON as follows:

Section I

That the Petition for Annexation known as the "Stalnaker Annexation" shown on Exhibit "A" and more particularly described on Exhibit "B" is hereby approved and said property shall be annexed into the City of Washougal.

Section II

The annexed property will be assessed and taxed at the same rate and on the same basis as property within the City of Washougal for any now outstanding indebtedness of the city, including assessments or taxes in payment of any bonds issued or debts contracted, prior to or existing at the date of annexation.

Section III

The zoning for the annexed properties shall be that which is identified in the City's preferred alternative plan.

Section IV

This ordinance shall take effect sixty-three (63) days after its passage and posting according to law.



Strategic Communications for Fire Levy Lid Lift

Thank you for talking with me about how we can help East County Fire and Rescue educate its community about a revenue request to support emergency services. This document serves as our proposal for strategic communication services for a November General Election.

On our call, we discussed the short and long-term goals of the fire district to maintain emergency service levels. In the short-term, it's imperative to return the fire levy to \$1.50 per \$1,000 of assessed property value. Long-term, it is important for the community to know that the fire district is looking at partnerships or consolidations to improve efficiencies and service. We anticipate educating the public about both issues as we move forward.

We also discussed the options available to educate our community about the proposal. The law says that you can share information about a potential ballot measure using communication methods already in place for the past calendar year. This means we can use a newsletter, one piece of direct mail, earned media, your web site and public outreach. With that in mind, this proposal outlines what we would do to best position East County Fire and Rescue for a positive outcome at the ballot box.

General Consulting

As part of this contract, we will develop a Scope of Work of communication projects to be completed that are outlined in this proposal. We also anticipate a monthly call (or calls as needed) to discuss strategy for the project with a select Communications Group once we are ready to move forward. Members of the Communications Group should be the chief his management team, a member of the labor union and volunteer groups, and a citizen supportive of the fire district.

During this project, issues could arise where East County Fire and Rescue requires strategic communications or public relations assistance. This could come in the form of something as simple as preparing responses to questions from the public, or managing opposition to the project. Or, it could be helping the fire district respond to an issue independent of the ballot measure that could impact the outcome of the election. We provide our clients with this type of public relations assistance 24-hours a day, 7-days a week for the length of our contract.

Message Development

Key messages are essential to any communication project. They drive your agenda with the public, and focus the attention of your audience. They make an organization proactive in its



communication efforts, as opposed to reactive. Most importantly, it helps keep your agency organized.

We will develop three to five key messages for the project that resonate with the public. These messages become the basis for all communication efforts with the public and news media. Once approved by the Communications Group, the information is shared with all emergency personnel (or associated staff) so message is consistent throughout the organization.

Strategies and Tactics for Message Delivery

There are three components that we can use to deliver our messages and reach as broad an audience as possible. These include:

Paid Communications – Paid communication pieces are important because we control timing, message and delivery of the information. These communication projects include anything that the fire district pays to produce.

For this project we are recommending two newsletters and one piece of direct mail about the ballot measure. These pieces must be sent to all households as required by law.

Earned Media Strategy – Earned media is the most cost-effective way to deliver key messages to an audience. Partnering with the local news media is a valuable way to share information with the public. Earned media projects we would complete for this project could include:

- Developing a media list to share information
- Designing an electronic news template
- · Regular news releases
- Prepared media responses
- Letters to the editor
- Opinion-editorial pieces
- · Editorial board visits
- Blog Posts, or content for electronic news boards

Owned Media – This category includes assets owned by the fire district that can be used to deliver key messages to the community. We anticipate providing text and materials for the fire district's web site.

Public Outreach – Public outreach is important for the community to see that the fire district is open, transparent and accessible to the community. Our goal is to identify the most effective public outreach efforts depending on available staff time. These could include:

- Developing a spokesperson for the project
- Designing a PowerPoint presentation to share with the community
- Providing direction for public meetings to share information and answer questions



Budget

The cost for us to manage a ballot measure and implement this plan is \$3,750 per month plus reasonable and approved expenses. We would start work no later than March 15, 2018 and continue through mid-November to manage the election outcome as needed.

In addition to labor, the fire district should anticipate expenses for printing, data, postage, and handling charges for the newsletters and direct mail piece. These would be billed directly to the fire district by our vendors or those of your choosing.
