AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of East County Fire and Rescue from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Small and attractive assets
- Payroll – gross wages and leave balances

INFORMATION ABOUT THE DISTRICT

East County Fire and Rescue, formerly Clark County Fire Protection District No. 9, provides fire services to approximately 10,057 residents. The District's service area covers a 60 square-mile rural residential area bordering the cities of Washougal and Camas.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's operations as well as its 17 employees and 28 volunteers. In 2013 and 2014, the District operated on annual budgets of approximately \$2.36 million and \$2.43 million, respectively.
